

2008 DI/HI AND DUO VIDEO LICENSING AGREEMENT

THIS LICENSE AGREEMENT, is only for active NFL school memberships, and is entered into by and between the National Forensic League ("NFL") and the under-signed ("Licensee") on the date below.

For valuable consideration, the undersigned hereby agree as follows:

Licensed Use: Licensee is granted a non-exclusive right to use the NFL Final Round Interpretation video tapes/DVDs ("the video tapes/DVDs") described in Attachment A, in, and only in, the following circumstances:

- A. Classroom showing as part of a regularly scheduled curricular class in Speech, English, Forensics or Debate in NFL member schools only.
- B. Classroom showing as part of school sponsored NFL chapter meetings, practice sessions or tournaments.
- C. Classroom showing to school district administrators, teachers, school board members, or parents of NFL member schools.

Restrictions on Use: Licensee agreements to abide by the following restrictions on the use of the video tapes/DVDs. Licensee shall not:

- A. Show, loan or distribute or loan the video tapes/DVDs in any way to non NFL members such as schools, students, parents or administrators.
- B. Publicly exhibit the video tapes/DVDs including but not limited to public meetings, gatherings, and television or cable broadcasts.
- C. Sell, rent, show or otherwise distribute the video tapes/DVDs for any monetary value or consideration.
- D. Use the video tapes/DVDs for any purpose other than those described in the above licensed use.

Ownership: Except as otherwise provided in this license agreement, you acknowledge that the NFL is the owner of all rights in the video tapes/DVDs.

Termination: Licensee agrees that this license agreement will terminate automatically if Licensee fails to comply with any of the terms of this license agreement, and on any such termination, Licensee will cease to use any of the video tapes/DVDs. Upon termination Licensee will immediately return all video tapes/DVDs and copies to the NFL.

Breach: Licensee agrees to assume any and all liability resulting from Licensee's noncompliance with the terms of this license agreement.

Damages: Licensee agrees that in no event shall the NFL be liable for any special, indirect, incidental or consequential damages in any way relating to the use, or arising out of the use, of the video tapes/DVDs.

General: Licensee acknowledges that they have read this license agreement, understand it, and agree to be bound by its terms.

Governing Law: This Agreement and performance hereunder shall be governed by the laws of the State of Wisconsin.
